- 1. Consideration of Apologies for Absence** - Cllrs Linda Cooper & David Wood. District Cllr Yvonne Peacock and Website Administrator Mrs P Pointon
- 2. Minutes of Parish Council meeting held on** - The minutes of the meeting held on 9th October 2025 were approved as a true and correct record.
- 3. Declaration of interest** - Cllr Sayer declared an interest in Item 7 Planning R/53/24H
- 4. Matters arising from the last meeting** - none
- 5. Highways/Street Lights/Bins**

Clerk read out e mail received from Highways dated 10.10.25 with updates on:

- **Thornton Rust Pot holes** - The pot holes which met intervention levels had been repaired
- **Tip Lane, Aysgarth** - Highways have raised a works order for the compacted mud and gravel to be scraped off the carriage way (will be completed by 07.11.25)
- **Traffic Monitoring, Newbiggin** - Enquiries into implementing some traffic monitoring will be made by Highways
- **Response from Structures Team Bishopdale** - 'There is a potential scheme at Bishopdale Bridge (known as Rookery Bridge) to be jointly developed between the Highways and Bridges Teams. At present, no resources have been allocated to the scheme, and it has not progressed beyond the optioneering phase. Realistically, it is unlikely to advance to site before the 2027/28 financial year at the earliest, subject to resource being made available. Currently, the proposal is to realign the highway approaches at one or both ends of the structure. The structure will not be widened, but the existing timber/metal fence will be replaced potentially with a stone parapet. There is still work to do to ensure that this option can be progressed, such as a preliminary highway design, visibility splay investigation, utility searches and ownership enquiries etc. In terms of the structure's condition, the most recent inspection in 2024 identified some minor issues. Aside from the parapet, there were no defects requiring urgent intervention. The next inspection is scheduled for 2026, at which point the structure's condition will be reassessed. We acknowledge that this structure has been an ongoing concern for several years and understand the ongoing interest.'

RESOLVED - Action - Clerk to contact the appropriate third parties

- **Keslpring, Aysgarth to Thornton Rust Rd** - It was noted that the issues regarding flooding at Kelspring, had still not been addressed by Highways which was puzzling given it was the main diversion route when the A684 is flooded. **Action - Clerk to e mail Highways to say that the Parish Council would like to know why Highways have not responded to PC e mails and appear not to consider it an issue.**
- **Trees Thornton Rust** - Cllr Cromey-Hawke had liaised with Open Reach and it needs to be a person rather than a body. It was resolved that Cllr Cromey-Hawke would continue to liaise on behalf of the Parish Council

- **Accident hotspot on bend near Nelhome, Aysgarth** - It was noted that Highways had put some traffic cones out

New Applications

R/53/12E/LB - Section 19 application to vary Condition 2 (approved drawings) of R/53/12D/LB (Listed building consent for alterations and repairs to existing dwelling and conversion of adjoining barn to provide additional domestic accommodation) for the addition of 2 no. cast iron SVPs and a single extract grille to rear elevation, along with the removal of 2 no. existing and redundant UPVC soil vent pipes at East Howgill, Bishopdale DL8 3TG - **The Parish Council had no comment to make.**

R/51/151 - Full planning permission for the erection of a timber-clad land management shed on a concrete padstone and block base, for the secure storage of land management equipment and housing a small composting toilet to support occasional maintenance visits at Warrthwaite (GR 399891 488641), Aysgarth, DL8 3AJ.

YDNPA had agreed to PC's request for an extension from the original close date of 28.10.25 to 21.11.25. Cllr Windle gave his views which he had based on the YDNPA Local Plan of 2015-2030 as to why he thought the Parish Council should object to the application. Cllr Cromey-Hawke set out why he felt that the Parish Council did not have grounds to object. The Parish Council took a vote, Cllr Windle voted to object. The other 7 Councillors present at the meeting voted not to object but felt that should the YDNPA approve the application, there should be conditions imposed. **RESOLVED - Action - Clerk to e mail YDNPA thanking them for the extension and stating that the Parish Council has resolved to leave determination to the YDNPA, but kindly request that any approval includes conditions to:**

- limit the development strictly to land-management use (not residential or camping);
- control materials, lighting, and appearance to reduce visual impact;
- remove and reinstate the ground when no longer needed for the purpose applied;
- protect the public footpath, trees, and river environment; and
- ensure proper drainage and waste management
